**ORDINANCE NO. 690**

**AN ORDINANCE AMENDING THE FINES FOR SEATBELT VIOLATIONS BY AMENDING SECTION 182.1(d) OF THE 2016 EDITION OF THE STANDARD TRAFFIC ORDINANCE, AS ADOPTED BY ORDINANCE NO. 671, AND REPEALING ALL CONFLICTING ORDINANCES AND PARTS OF ORDINANCES OF THE CITY OF GARDEN PLAIN, KANSAS**

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GARDEN PLAIN, KANSAS:

**Section 1.     AMENDING SECTION 182.1(d) OF THE STANDARD TRAFFIC ORDINANCE**

Section 182.1(d) of the 2016 edition of the Standard Traffic Ordinance, as adopted by Ordinance No. 671, is hereby amended to read as follows:

- “(d) (1) Persons violating subsection (a)(1) shall be fined \$30 and no court costs;  
and  
(2) Persons violating subsection (a)(2) shall be fined \$60 and no court costs.”

**Section 2.     Repeal**

All ordinances or parts of ordinances in conflict herewith are repealed. However, any section of an existing ordinance not in conflict herewith is not repealed and remains in full force and effect.

**Section 3.     Effective Date**

This Ordinance shall take effect and be in force from and after its publication in the official City newspaper.
