RESOLUTION NO. 165

**A RESOLUTION ESTABLISHING PRICING AND SECURITY DEPOSITS FOR SOLID WASTE DISPOSAL IN THE CITY OF GARDEN PLAIN, KANSAS**

WHEREAS, the Governing Body of the City of Garden Plain, Kansas has established an ordinance governing the collection and disposal of refuse; and

WHEREAS, the Governing Body of the City of Garden Plain, Kansas seeks to establish uniform pricing for residential users for the Solid Waste Disposal services.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF GARDEN PLAIN, KANSAS:

1. The monthly service fee for the collection and disposal of refuse for the City of Garden Plain, Kansas shall be \$15.00 per month.
2. Any applicant for Solid Waste Disposal for a property occupied or to be occupied by a tenant, which property has previously not utilized the City's Solid Waste Disposal Services, shall deposit with the City Clerk a \$50 security deposit for such services.
